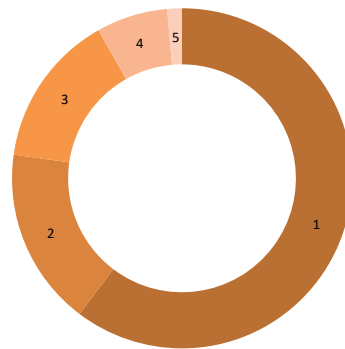

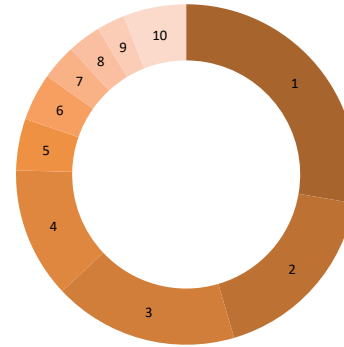

Sector allocation



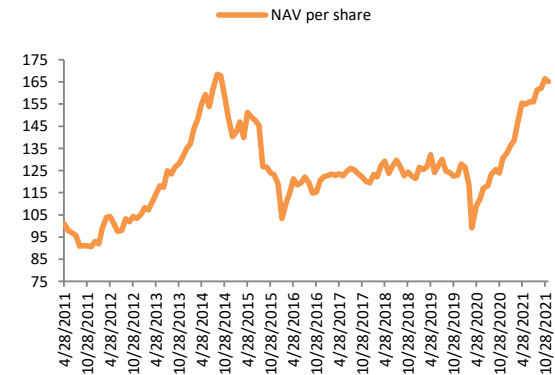
