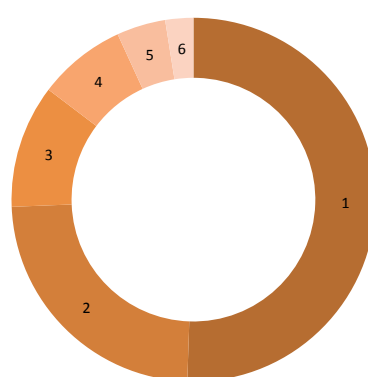

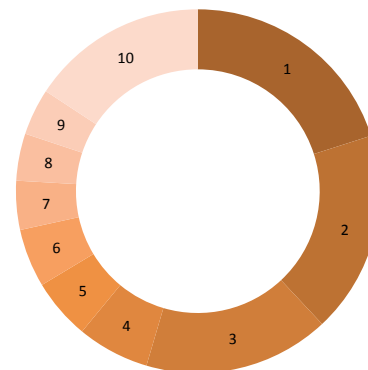

Sector allocation



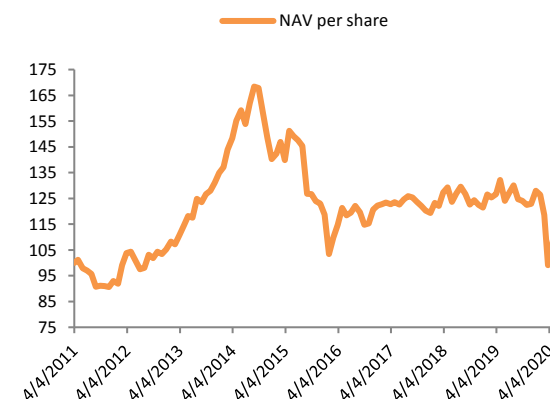
