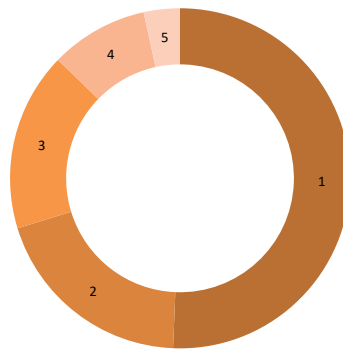

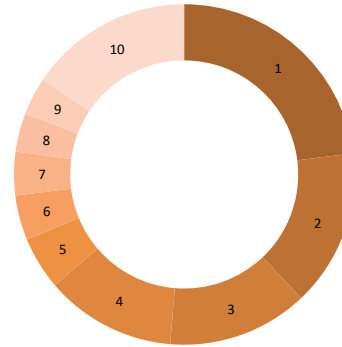

Sector allocation



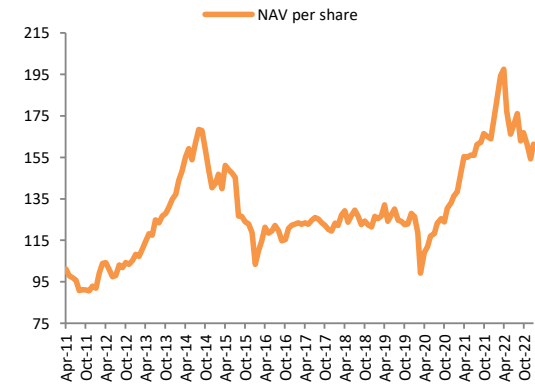
