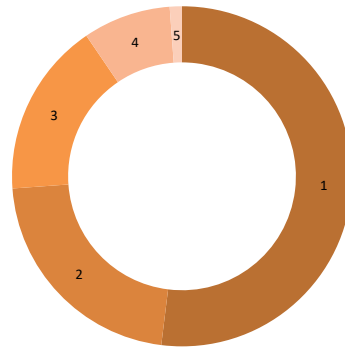

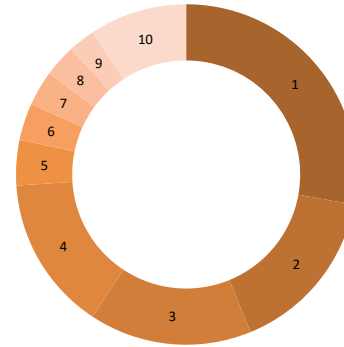

Sector allocation



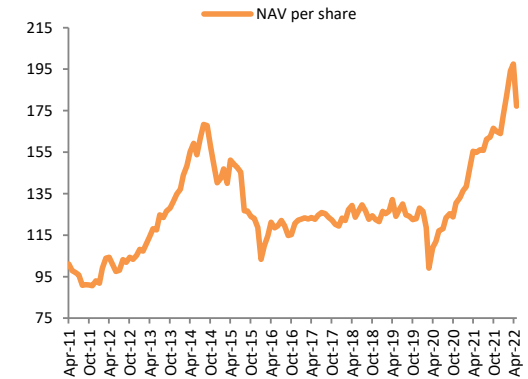
