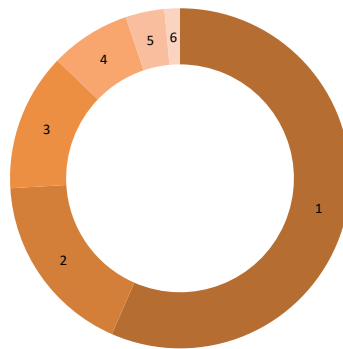

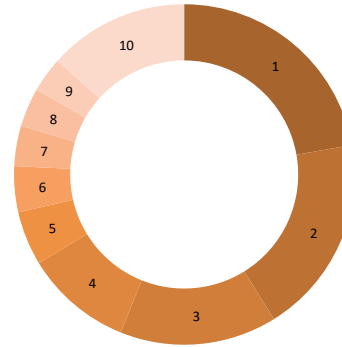

Sector allocation



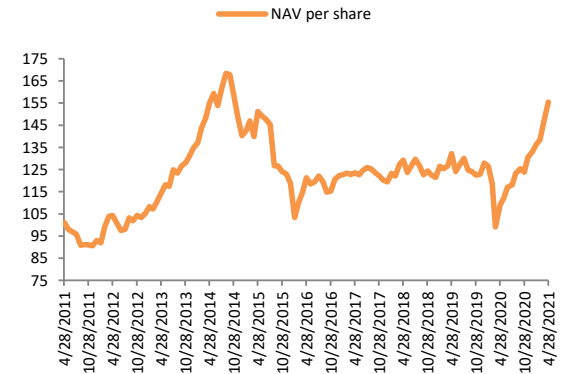
